Existing Regulation	Modification issued
The students will directly forward the applications for revaluation in the prescribed forms to the Kerala Agricultural University Head Quarters after remitting the fee in the college office concerned or Kerala Agricultural University Head Quarters within 15 days from the date of publication of result.	The Students should have to file revaluation applications in their concerned colleges for revaluation in the prescribed forms after remitting the fee in the college office concerned within 15 days from the date of publication of result.

All other conditions described in the clause 24.1 to 24.2 (page 27 of the Academic hand Book) and the university Orders cited 2nd related to the revaluation procedure remains unchanged. The time limit mentioned in the university circular cited 4th in the reference should strictly be adhered.
